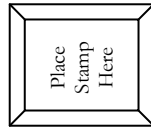

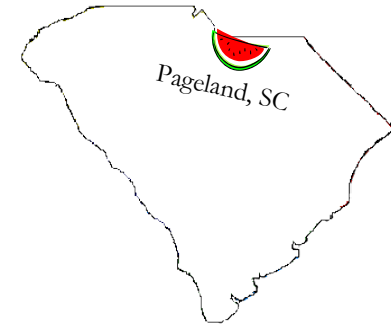
All vendor fees include permit and garbage pick up. It does NOT include water, sewer or electricity. Quiet generators are encouraged. You must contact us to request electricity and a fee must be included in your application.

Only 110 hook-ups may be available for craft vendors. Please remember that electricity will be limited. You must contact us to get approval to apply for electricity and you must make payment with application. You will be notified if there is a conflict in being able to provide you with power. Please only purchase power if it is necessary to run your booth (not for fans, radios, televisions, etc.)

**Rules & Regulations**

1. All vendors must obey all town, county, and state laws and regulations.
2. All vendors MUST be in their booths and set up no later than 30 minutes prior to the opening of each event day.
3. No items that may be used as weapons will be allowed. This includes (but is not limited to) marshmallow shooters, slingshots, knives and guns. Imitation weapons are also not permitted. Glass bottles are NOT permitted.
4. Vendors are to bring enough items to sell the duration of the event. No vendor is to breakdown their booth early.
5. There will be **NO** rain date. A registration is a commitment to the event and **no refunds** will be made (unless a vendor is not accepted).
6. Vendors may not sell any part of a space.
7. Canopies and tents, including any connecting ropes or wires, MUST be totally contained within the vendor's assigned space. Do not drill or hammer anything into the pavement. No trucks or automobiles are allowed in a space without prior approval.
8. Security will be provided Friday and Saturday nights. However, the Town of Pageland nor the Pageland Chamber of Commerce will be held responsible for loss or damage for any reason.

9. Applications must include a cashier's check or money order, photo of set-up, list of items for sale, and a self-addressed stamped envelope.
10. The submittal of an application is not a guarantee of acceptance in the event. The Chamber of Commerce reserves the right to refuse acceptance of any application. To insure greater variety and opportunity for vendors and customers, a limited number of vendors will be accepted in each category. The decisions on acceptance into the event and the placement of booths is determined by the director of the Chamber of Commerce, and all decisions are final. If you are not accepted to the event your payment will be returned.
